### Principles and Guidelines on Continuing Medical Education and Continuing Professional Development (CME/CPD)

### Effective from 1 January 2023

#### 1. Objective and Definition

It is the objectives of the Hong Kong Academy of Medicine (HKAM) and the College of Dental Surgeons of Hong Kong (CDSHK) to promote the advancement of the art and science of medicine, foster the development of postgraduate medical education and continuing medical education as well as promoting the improvement of health care for Hong Kong citizens. The purpose of CME/CPD is to meet these objectives.

CME/CPD is a continuous life-long learning process for Fellows of the HKAM and comprises activities that serve to:

- a) maintain, develop or increase the knowledge, skills and competencies relevant to the practice of Fellows that may change over the years;
- enhance professional performance to enable the delivery of quality professional care and safe standard of practice to the patients, and public that Fellows serve, and;
- c) ensure that Fellows will remain competent throughout their professional career.

#### 2. Supervision of CME/CPD

- **2.1** The CME/CPD programme will seek and receive formal approval from the Education Committee of HKAM before implementation.
- **2.2** Any changes to the CME/CPD programme will also be approved by the Education Committee of the HKAM before implementation.
- **2.3** All Fellows of the College who are also Fellows of the HKAM must satisfy the full requirements of the CME/CPD programme by the end of each cycle.
- **2.4** CDSHK will ensure compliance with CME/CPD requirements. Any non-compliance will be recorded and reported to the Education Committee of HKAM. The Education Committee of HKAM may recommend to the Council of the HKAM the suspension of

a Fellow who has failed to comply with CME/CPD requirements by the end of the cycle, unless the Education Committee is satisfied that there are relevant and exceptional circumstances (Please refer to Appendix II for HKAM Principles and Guidelines on CME/CPD 2023-2025 Point 8 and 9 for details). Furthermore, the Education Committee has to be satisfied that the shortfall can be remedied within an acceptable time.

- **2.5** An administration fee will be charged for re-issuing a revised CME report for the previous cycle.
- 2.6 All operational issues related to CME/CPD will be undertaken by the CME Sub-committee of CDSHK.

#### 3. CME Sub-committee

The CME Sub-committee deals with issues related to CME/CPD activities and their accreditation. The Vice-President (General Affairs & CPD) shall be the Chairman of the Sub-committee. The Chairman of the Sub-committee shall be a member of the Education & Examination Committee of CDSHK (EEC) and the Chairman of EEC shall be an ex-officio member of the Sub-committee. The members of the Sub-committee shall be nominated by the Chairman of the Sub-committee and appointed by the Council of CDSHK. There shall be not less than four and not more than ten members in the Sub-committee. The Terms of Reference of the Sub-committee will be determined and revised from time to time by the Council of CDSHK.

#### 4. Terms of Reference

The CME Sub-committee of CDSHK shall be responsible for implementing, monitoring and evaluating CME/CPD. The CME Sub-committee of CDSHK will scrutinize and approve meetings, conferences, seminars, workshops and other educational activities suitable for accreditation, to capture information on CME/CPD undertaken by each Fellow and to provide feedback to Fellows on their performance.

#### 5. The Cycle

- 5.1 A cycle of CME/CPD shall normally consist of three years.
- **5.2** Fixed CME/CPD cycles have been adopted since 1 January 2005. New Fellows will commence their first cycle on the first day of the month immediately after their admission to the Academy Fellowship; and the required CME/CPD points for the first cycle will be counted on a pro-rata basis.

**5.3** CDSHK will report to the Education Committee of HKAM any Fellow of the Academy who fails to comply with CME/CPD requirements at the end of the cycle. The Education Committee of HKAM will then consider such sanctions as are appropriate for recommendation to the Council of HKAM.

#### 6. The Credit Point System

- 6.1 In this credit point counting system, points are given and accumulated for the various approved CME/CPD activities in which Fellows participate. A minimum of ninety (90) points have to be accredited over a three-year cycle period, and an average of thirty (30) points per year should be the aim of Fellows.
- **6.2** CME/CPD points accumulated in excess of the requirement for one cycle cannot be carried forward to the next cycle.
- **6.3** It is strongly recommended that Fellows should maintain a balanced CME/CPD profile with a mix of different activities, including at least 5 points in a cycle from activities in quality assurance and related activities under section 8.4 and 8.7 in order to capture the full benefit of different types of CME/CPD activities.

#### 7. Measurement of activities

A point of CME/CPD activity is equivalent to one hour of participation as an attendee in a Formal College Approved Activity (FCAA).

The categories of FCAA are as follows:

- Category A: <u>Dentally-related FCAA</u> organized by CDSHK, or by organizations on the list approved by the CME Sub-committee from time to time.
- Category B: <u>Medically-related FCAA</u> organized by Colleges of HKAM, or by organizations on the list approved by the CME Sub-committee from time to time.
- Category C: <u>FCAA other than those in Categories A & B</u> including,
  - FCAA on topics only indirectly or partly related to dentistry or medicine (e.g. courses on relevant laws, information technology, clinic management, interpersonal communication, etc.);
  - (b) dentally-related FCAA organized by reputable organizations not on CDSHK pre-approved list;
  - (c) submission of claims to dentally-related FCAA (local or overseas) without prior approval;

Passive – Passive CME Point <item 8.1>

8.

- 8.1 Participation as an attendee in FCAA
  - a) One hour of participation as an attendee at a FCAA is ordinarily accepted as the basic unit of CME/CPD (1 point).
  - **b)** Criteria to accredit any FCAA will be determined by the CME Sub-committee.
  - c) CME/CPD points will be recorded for those who have signed the Attendance Form; otherwise, proof of attendance must be submitted to the CME Sub-committee for documentation.
  - **d)** Participation as defined above may be awarded a maximum of 25 points for any single FCAA.
  - e) Participation as defined above may be awarded a maximum of 75 points per 3-year cycle, including a maximum of 30 points from Category B and/or a maximum of 30 points from Category C.

#### Non-Passive CME Points <items 8.2 – 8.15>

- 8.2 <u>Chairing/Presenting in FCAA</u> 8.2.1 <u>Chairing in FCAA</u>
  - **a)** Chairing in a FCAA may be awarded 1 point per hour with an additional 1 point per morning, afternoon or evening session.
  - **b)** Participation as chairing in a FCAA may be awarded a maximum of 15 points for any single FCAA.
  - c) Participation as defined above may be awarded a maximum of 45 points per 3-year cycle, including a maximum of 15 points from Category B and/or a maximum of 10 points from Category C.

#### 8.2.2 Presenting in FCAA

- d) Presenting in a FCAA may be awarded 3 points per hour.
- e) Participation as presenting in a FCAA may be awarded a maximum of 25 points for any single FCAA.
- f) Participation as defined above may be awarded a maximum of 75 points per 3-year cycle, including a maximum of 15 points from Category B and/or a maximum of 10 points from Category C.

#### 8.2.3 Presenting to Paramedical Personnel

- **g)** The activity should be held by the pre-approved CME provider or in a conjoint activity with pre-approved CME provider.
- h) Presenting to Paramedical Personnel may be awarded 3 points per hour.
- i) Participation as defined above may be awarded a maximum of 12 points per 3-year cycle.

**j)** The number of participants should be more than 10 and the name list should be submitted for accreditation.

#### 8.3 <u>Self-study</u>

- a) Self-study is accepted as a form of CME/CPD.
- **b)** One hour of self-study is ordinarily awarded 1 point.
- c) Self-study is only accredited with the necessary evidence that it has been carried out diligently by submission of a duly completed Self-study Form.
- d) Self-study may be awarded a maximum of 45 points per 3-year cycle.
- e) On-line learning is accredited as self-study only with materials uploaded on the websites of the HKAM or its constituent Colleges, or materials as approved by the CME Sub-committee from time to time.
- **f)** Materials for self-study must be those published within the last 3 years counting from the date the activity is claimed.

#### 8.4 <u>Self-arranged Study Group</u>

- **a)** Study group in the form of experience sharing for clinical dental cases is accepted as a form of CME/CPD.
- **b)** The size of the group should be kept in the range from 4 to 8.
- **c)** 4-8 participants must include at least 1 Fellow and at least 3 other participants should be the College members (i.e. Fellows / MGD Holders / Higher Trainees)
- d) Non pre-approved organization should seek prior approval
- e) During the conduction of the activity, rules governing the confidentiality of patient information must be observed.
- f) Submission of case summaries and attendance form are mandatory.
- g) A maximum of 1 point may be awarded for each activity.
- h) Study group activities may be awarded a maximum of 15 points per 3-year cycle.

#### 8.5 <u>Hands-on Courses</u>

- a) Participation in hands-on clinical or laboratory courses may be awarded 1.5 points per hour.
- **b)** Participation as defined above may be awarded a maximum of 25 points for any single FCAA.
- c) Participation in hands-on clinical or laboratory courses as trainers may be awarded 2 points per hour.
- d) Hands-on courses may be awarded a maximum of 45 points per 3-year cycle, including a maximum of 15 points from Category B and/or a maximum of 10 points from Category C.

#### 8.6 <u>Publications</u>

- **a)** A maximum of 10 points may be awarded to the first author and 5 points for other authorship of each publication in indexed journals.
- b) A maximum of 5 points may be awarded to the first author and 2 points for other authorship of each publication in other journals approved by the CME Sub-committee.
- c) A maximum of 10 points may be awarded to the first author and 5 points for other authorship of each chapter or section of a medical/dental textbook.
- d) A maximum of 10 points may be awarded to the author of a thesis or treatise.
- e) Publications may be awarded a maximum of 30 points per 3-year cycle.

#### 8.7 Quality Assurance, Audits and Activities for Improvement of Patient Care

- a) Quality assurance activities, such as clinical/service review and audit, clinical governance, peer review of operative practice, activities that examine the clinical care of patients or individual practice, and patient safety enhancement programme, may attract CME/CPD points on the basis of 1 point per hour.
- **b)** A maximum of 2 points may be awarded for each activity.
- **C)** Quality assurance activities may be awarded a maximum of 30 points per 3-year cycle.

#### 8.8 <u>Postgraduate Courses</u>

- **a)** Attendance of an approved full-time course leading to a postgraduate qualification may be awarded 10 points a year.
- b) Attendance of an approved part-time course leading to a postgraduate qualification may be awarded 5 points a year.
   Note : Qualification attainable after completion of the course should be registrable in

#### 8.9 Development of CME/CPD Materials

the Dental Council of Hong Kong.

- **a)** Development of CME/CPD materials for self-study or on-line learning may be awarded 2 points per submission.
- **b)** Such an activity may be awarded a maximum of 30 points per 3-year cycle.

#### 8.10 <u>Conducting Examination</u>

**a)** Participating as an examiner in an examination conducted by CDSHK may be awarded a maximum of 10 points for any single examination. Such participation may be

awarded a maximum of 30 points per 3- year cycle.

**b)** Setting examination questions for examination conducted by CDSHK may be awarded a maximum of 3 points for any examination. Such participation may be awarded a maximum of 9 points per 3-year cycle.

#### 8.11 <u>Performing Training duties</u>

- a) Performing training duties as an approved trainer can be awarded a maximum of 10 points per trainee for a single year. No more than 30 points can be awarded for a single trainer per 3-year cycle.
- **b)** Performing training duties as an approved MGD mentor can be awarded a maximum of 7 points per mentee for a single year. No more than 21 points can be awarded for a single mentor per 3-year cycle.

#### 8.12 <u>Reviewers of indexed journals and approved journals</u>

- a) Participation in reviewing articles submitted to indexed journals and approved journals may be awarded 2 points per article.
- **b)** Reviewers may be awarded a maximum of 20 points per 3-year cycle.

#### 8.13 <u>Research</u>

Research activities per se do not attract any CME/CPD point. Output from research activities may be awarded CME/CPD points under the category of Presenting in FCAA or Publications.

#### 8.14 <u>Undergraduate and Postgraduate Teaching</u>

Undergraduate and postgraduate teaching may be accepted as a form of CME/CPD, subject to a quality assurance process and a maximum of 3 points per year.

#### 8.15 Development of New Technology or Services

The development of new technology or services in itself does not attract any CME/CPD point. CME/CPD points may be awarded under the category of Presenting in FCAA or Publications.

#### 8.16 Development of Course Materials in eHKAM LMS

a) Development of Course Materials in eHKAM LMS may be awarded 3 points per hour, including quiz or evaluation for the participants. (A presentation of not less than 15

minutes will be counted as half-an-hour, accredited with 1.5 CME/CPD points)

- **b)** Renewal of the Course Materials and/or quiz (evaluation) in eHKAM LMS may be awarded 1 point per hour of the presentation per year.
- c) Participation as defined above may be awarded a maximum of 75 points per 3-year cycle, including a maximum of 15 points from Category B and/or a maximum of 10 points from Category C.

#### 9 CME/CPD Registry

The CME Sub-committee will maintain a Register of Fellows and non-Fellow specialists who are required to undergo the mandatory CME/CPD Programme of HKAM. At the end of each cycle, those who fail to fulfill the requirements of CME/CPD will be reported to HKAM for further action. Please refer to the most updated HKAM Principles and Guidelines on CME/CPD for information concerning non-compliance.

#### 10 Enquiry

If there is doubt regarding any FCAA, Fellows should seek clarification from the CME Sub-committee. In the event of dispute, the decision will rest on the CME Sub-committee. Each and every case will be discussed and the accreditation of any case will depend on individual merits.

#### 11 Appeal System

Any Fellow who does not agree with the CME Sub-committee's decision may make an appeal to the Council of CDSHK, in writing, stating the reason(s) of disagreement. The Council will include the appeal in the agenda of a Council Meeting and make a final decision. The Council may support or overrule the CME Sub-committee's decision; and will advise the CME Sub-committee and the Fellow concerned accordingly.

# Principles and Guidelines on Continuing Medical Education and Continuing Professional Development (CME/CPD) for Cycle 2023-2025

#### 8. *Exemptions*

#### 8.1 Retired from Active Practice

- a) The Academy will consider application for CME/CPD exemption from a Fellow only if he has formally submitted a written declaration to the Academy / College that he has retired from active practice in and outside Hong Kong.
- b) A Fellow holding multiple Fellowships cannot claim retirement from active practice for one specialty while still practising the other specialty / specialties. A Fellow can apply for suspension of a Fellowship for which he chooses not to continue with CME/CPD.
- c) A retired Fellow who subsequently wishes to resume active practice will be required to have obtained at least 90 CME/CPD points within 36 months counting back from the date of application in order to resume medical practice. A pro-rata number of the 90 points required must be obtained within the period between the date of retirement and the date of application for resuming practice. Should a retired Fellow resume medical practice before he can fulfil the CME/CPD requirements as aforementioned, he will lose his status as a retired Fellow and his Fellowship will be suspended accordingly.

#### 8.2 Acute / Prolonged Illness and Permanent Disability

- a) A Fellow who falls behind CME/CPD because of acute / prolonged illness or permanent disability can be exempted from the CME/CPD requirements, on condition that he is not in active practice.
- *b)* An illness can be accepted as "prolonged illness" provided a sick leave of at least 6 months has been formally granted within a 3-year cycle (pro-rata count may apply in case the cycle is less than 3 years);
- c) Partial exemption will be considered and approved by the Education Committee of the Academy on a case by case pro-rata basis depending on the extent of the illness and its impact on practice. The guiding principle of exemption is that when a Fellow is not in active practice because of the illness, CME/CPD requirement of that total period of "not in active 7 practice" will be exempted for CME/CPD in that cycle, while pro-rata count of CME/CPD requirement will be applied to the period(s) during which the Fellows are in active practice.

#### 9. Non-compliance

9.1 Non-compliance That Is Remediable a) A Fellow must: i) have achieved not less than two-thirds of the required number of points for a cycle; or ii) be certified to have suffered from a medical condition which the Council of the Academy considers as a reasonable cause for the CME/CPD non-compliance. The Academy may, at its discretion, accept other conditions if supported by the College of the Fellow on reasonable grounds. b) The Fellow must engage in a remedial programme to make up for the deficiency. c) The reason for non-compliance and the remedial programme must be endorsed by the Education Committee and Council of the Academy. d) The remedial programme must be finished within the time specified by the appropriate College. In any case, the remedial programme must be finished within 12 months from the end of the cycle concerned. e) The next cycle shall follow immediately after the previous cycle without any break, i.e. the Fellow will have to undergo normal and remedial CME/CPD at the same time.

#### 9.2 Non-compliance That Is Not Remediable

For Fellows who have obtained less than two-thirds of the required number of points for a cycle without acceptable reasons, a recommendation for Fellowship suspension will be made. Reinstatement of Academy Fellowship shall be subject to the conditions stipulated in the Academy policy paper entitled "Reinstatement of Fellowship".

#### 2. Guidelines for on-line CME activities

General Principles:

Accreditation of web-based/online CME activities (e.g. webinar) is based on interalia, assurance from event organisers that they will:

- a) establish proper registration procedures with means to verify the identity of participants.
- b) implement appropriate and feasible measures to ascertain participants attendance and reasonable participation for the purpose of awarding CME points (e.g. a requirement on expected duration of participation, satisfactory completion of a post–event quiz, questionnaire or feedback form, or other methods).

Operation Guidelines:

- a) Event organizers shall provide relevant information and supporting evidence when applying for CME/CPD points.
- b) The College will consider the said evidence when deciding whether to grand CME/ CPD points to the activity in question.
- c) The minimum requirements for a participant to achieve reasonable participation are as follows:

- i. The participant must register online personally; registration by proxy would not be suffice.
- ii. Upon request and as appropriate to the particular activity concerned, the participant must turn on the camera on his/her viewing device and show his/her face; the display of a still image would not constitute participation.
- iii. The participant must show his/ her full name on screen where appropriate upon request.
- iv. CME activities delivered online with live streaming subject to prior accreditation could be accredited with CME and such allocation of CME points for online CME activities is in the same manner as that for CME activities requiring physical attendance.
